



### DESCRIPTION and RULES:

- **Street Fighters** is a Street Dance "Crew vs Crew" competition (**Choreo + Freestyle**);
- Pre-selections are open to crews composed of Dancers Over 18 (born before 2007 inclusive);
- Each group will have the option to participate in multiple stops;
- Crews must always be composed of a **minimum of 3 members**;
- The showcase duration should be a maximum of **4:30 minutes**; if the choreography exceeds this duration, it will be penalized by **20% of the total score**;
- **Showcases** will determine the best **2 or 4 crews** (at the jury's discretion) who will compete in a **Freestyle Battle**(crew vs crew - mixed style) lasting **10 minutes**;
- Street Fighters World Tour 2025 stops outside Italy (on-site, online, or by invitation) will be managed by **local organizations**, and it will be their responsibility to determine access methods and participation fees;
- Each individual stop of the World Tour 2025 represents the only opportunity to access the **World Final** scheduled for: **Friday 18th July 2025** on the **Main Stage of The Week** in Cesenatico;

### JUDGING SYSTEM:

- Technical Jury will be composed of at least **3 qualified Judges**;
- The crew will be judged according to the following **Criteria**:
  - **Show**: Choreography development, scenic impact, synchronization, and movement execution;
  - **Technique**: precision and quality of dance styles;
  - **Style**: flow, musicality, movement quality, stage presence, and attitude
- **Crew vs Crew Battles** will be judged according to the criteria of: **Technique, Style, and Battle Attitude**;
- Jury decisions are final.

Winning Crews from each **selection stop** will be **OBLIGATED** to participate in:

**Friday 18th July 2025 @ The Week** ⇒ Main Stage - Piazza Spose dei Marinai, **Cesenatico** (FC)

**PRIZE POOL:**

- Winning crews from each Italian Street Fighters Stop will receive a **flat-rate expense reimbursement** from the Local Organization for participation in the **World Final**; The amount will be determined based on the origin of the winning crews;
- The Winning Crew of **STREET FIGHTERS WORLD FINAL @ THE WEEK 2025** will win the **Street Fighters Trophy** handmade by artist Virzi + a cash prize of **€ 1,000.00**

**IMPORTANT:**

- The local organization reserves the right to cancel one or more selection stops if compelling "Force Majeure" reasons arise;
- If insufficient registrations are received to allow competition within one or more selection stops, the stop will be canceled;
- The Organization reserves the right to record, film, broadcast on television, partially or entirely, participants' performances in Street Fighters, along with their image and name, through television, radio, and multimedia means;
- Golden Age S.S.D. A R.L. authorizes Local Organizations to acquire and use (unless written objection) personal data provided by each participant for promotional, informative, and statistical purposes in accordance with current laws;
- Street Fighters participants declare they are in good health as per medical certificates in their possession. The Organizer declines all responsibility for damages to property or persons that may occur during the various stages of the event, whether suffered or caused by the contest participants or their companions;
- Participation in Street Fighters implies unconditional acceptance of these Regulations and any additional rules that the organization reserves the right to introduce, which will have equivalent value to these Regulations. In case of non-compliance with the provisions of these Regulations, the Organization may adopt the measure of expulsion from the Contest.
